# **Privacy Policy**

#### Introduction

CLE Tracker is committed to protecting your privacy through compliance with this privacy policy (the "Policy").

The Policy describes information which may be collected from you or that you may provide when you visit the application/website CLE Tracker (the "App/Website") and the practices for collecting, using, maintaining, protecting, and disclosing that information.

# This Policy applies to information we collect:

- On the App/Website;
- Via emails, texts, and other electronic messages between you and the App/Website;
- Via mobile applications and desktop applications you may download from the App/Website which provides dedicated non-browser-based interaction between you and the App/Website; and
- When using our products and services.

## It does not apply to information collected:

- By the App/Website offline or through any other means, including on any other website operated by the App/Website or any third party (including any affiliates and subsidiaries); or
- Any third party (including our affiliates and subsidiaries), including through any application or content (including advertising) that may link to or be accessible from or on the App/Website.

Please read this policy carefully to understand the policies and practices regarding your information and how it will be treated. If you do not agree with the policies and practices, your choice is not to use the App/Website. By accessing or using the App/Website, you agree to this Policy. This Policy may change from time to time. Your continued use of the App/Website after changes are made shall be deemed to be acceptance of those changes. Please check the Policy periodically for updates. Any/all capitalized terms not defined herein have the definitions in Terms and Conditions.

# Children Under the Age of 16

The App/Website is not intended for use by children under 16 years of age. No one under age 16 may provide any personal information to or on the App/Website. We do not knowingly collect personal information from children under 16. If you are under 16, do not use or provide any information on this App/Website or via any of its features, register on the App/Website, make any purchases through the App/Website, use any of the interactive or public comment features of this App/Website, or provide any information about yourself, including your name, address, telephone number, email address, or any screen name or user name you may use. If the App/Website learns that it has collected or received personal information from a child under 16 without verification of parental consent, said information will be deleted. #### Information Collected and How Information is Collected

# Several types of information may be collected from and about users of the App/Website, including, but not limited to, information:

- By which you may be personally identified, such as name, postal address, e-mail address, telephone number, comments, and postings, the times you visited the App/Website and any other identifier by which you may be contacted online or offline ("personal information");
- That is about you but independently does not identify you, such as what portion of our App/Website you have browsed; and/or
- About your internet connection, the equipment you use to access the App/Website, and usage details.

# Information may be collected:

- Directly from you when you provide it to the App/Website;
- Automatically as you navigate through the App/Website. Information collected automatically may include usage details, IP addresses, and information collected through cookies, web beacons, and other tracking technologies; and/or
- From third parties, for example, business partners.

## **Information Provided by User**

# The information collected through the App/Website may include:

- Information that you provide by filling in forms on the App/Website. This includes
  information provided at the time of registering to use the App/Website, subscribing
  to related services, posting material, or requesting further services. You may be
  asked for information when you fill out a survey, a contest or promotion sponsored
  by the App/Website, and when you report a problem or concern with the
  App/Website.
- Records and copies of correspondence (including email addresses), if you contact the App/Website.
- Responses to surveys that the user may be asked complete.
- Details of transactions that the user may engaged in through the App/Website.
- Search queries on or through the App/Website.
- The user also may provide information to be published or displayed ("posted") on public areas of the App/Website, or transmitted to other users of the App/Website or third parties (collectively, "User Contributions"). User Contributions are posted on and transmitted to others at the user's own risk. Although access to certain pages may be limited, please be aware that no security measures are perfect or impenetrable. Additionally, the App/Website cannot control the actions of other users of the App/Website with whom a user may choose to share User Contributions. Therefore, the App/Website cannot and does not guarantee that the user's User Contributions will not be viewed by unauthorized persons.

# **Information Collected Through Automatic Data Collection Technologies**

As the user navigates through and interacts with the App/Website, automatic data collection technologies may be used to collect certain information about the user, equipment, browsing actions, and patterns, including, but not limited to:

 Details of the user's visits to the App/Website, including traffic data, location data, logs, and other communication data and the resources that the user accesses and uses on the App/Website; and/or  Information about the user's computer and internet connection, including IP addresses, operating systems, and browser types.

The information collected automatically is only statistical data and does not include personal information, but the App/Website may maintain it or associate it with personal information collected in other ways or received from third parties. It assists the App/Website in improving and to deliver a better and more personalized service, including by enabling the App/Website to:

- Estimate the audience size and usage patterns.
- Store information about user preferences, allowing to customize the App/Website according to individual interests.
- Speed up your searches.
- Recognize when a user returns to the App/Website.

# The technologies possibly used for automatic data collection may include:

- Cookies (or browser cookies). A cookie is a small file placed on the hard drive of
  your computer. A user may refuse to accept browser cookies by activating the
  appropriate settings on your browser. However, if a user selects this setting the user
  may be unable to access certain parts of the App/Website. Unless the user has
  adjusted their browser setting so that it will refuse cookies, the App/Website system
  may issue cookies when the user directs their browser to the App/Website.
- Web Beacons. Pages of the App/Website and e-mails may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit the App/Website, for example, to count users who have visited those pages or opened an email and for other related website statistics (for example, recording the popularity of certain website content and verifying system and server integrity). The App/Website does not collect personal information automatically, but it may tie this information to personal information about the user that is collected from other sources or provided by the user.

# **How User Information May be Used**

Subject to the terms of this Privacy Policy, the use of information collected about the user or provided by the user, including any personal information may be used:

- To present the App/Website and its contents to the user.
- To provide the user with information, products, or services that may be requested by the user.
- To fulfill any other purpose for which the user provides said information.
- To provide the user with notices about user accounts, including expiration and renewal notices.
- To provide the user with notices about user CLE credits.
- To carry out our obligations and enforce the App/Website's rights arising from any contracts entered into between the user and the App/Website.
- To notify the user about changes to the App/Website or any products or services offered or provided through it.
- To allow the user to participate in interactive features on the App/Website.
- To allow speakers and partners of the App/Website to communicate with the user, and offer third party products and services.
- In any other way the App/Website may describe when the user provides the information.
- For any other purpose with the user's consent.

The App/Website may also use user information to contact the user about the App/Website's own and third-parties' goods and services that may be of interest to the user.

#### **Disclosure of Your Information**

Subject to the terms of this Privacy Policy, we may disclose aggregated information about our users, and information that does not identify any individual, without restriction.

We may disclose personal information that we collect or you provide as described in this privacy policy:

 To your employer if you accessed our App/Website through an account created by your employer.

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties we use to support our business.
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of the App/Website's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by the App/Website about the App/Website's users is among the assets transferred.
- To fulfill the purpose for which you provide it.
- For any other purpose disclosed by us when you provide the information.
- To a third-party vendor.
- With your consent.

## We may also disclose your personal information:

- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- To enforce or apply our Terms and Conditions and the App/Website Profile Terms and Conditions and other agreements, including for billing and collection purposes.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of the App/Website, our customers, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.

## **Choices About How We Use and Disclose Your Information**

We strive to provide you with choices regarding the personal information you provide to us. We have created mechanisms to provide you with the following control over your information:

 Tracking Technologies and Advertising. You can set your browser to refuse all or some browser cookies, or to alert you when cookies are being sent. To learn how you can manage your Flash cookie settings, visit the Flash player settings page on Adobe's website. If you disable or refuse cookies, please note that some parts of this site may then be inaccessible or not function properly. • **Disclosure of Your Information for Third Party Advertising**. Proper access and use of information provided on the App/Website, including your inputted information, is governed by our Terms and Conditions and the App/Website Profile Terms and Conditions.

# **Data Security**

The safety and security of your information also depends on you. Where we have given you (or where you have chosen) a password for access to certain parts of our App/Website, you are responsible for keeping this password confidential. We ask you not to share your password with anyone. We urge you to be careful about giving out information in public areas of the App/Website like message boards. The information you share in public areas may be viewed by any user of the App/Website.
